

Professional Licensure Disclosure

The curriculum for programs customarily leading to licensure or certification at Capital University have been designed to meet requirements in Ohio. Students planning to pursue licensure or certification in any state other than Ohio need to review the professional licensure disclosures pertaining to their program and state educational requirements for licensure and certification. State licensing boards determine eligibility for licensure based on the rules and regulations within their state at the time an individual submits their application for licensure.

State Authorization

Capital University is a member of the National Council for State Authorization Reciprocity Agreement (NC-SARA) which allows us to provide distance learning programs and coursework to residents of states other than Ohio. NC-SARA membership does not provide reciprocity or exemption from state professional licensing requirements. Licensing and certification requirements in Ohio may not be recognized as sufficient to obtain a license or certificate in another state.

Athletic Training

Capital University is currently accredited by the Commission on Accreditation of Athletic Training Education (CAATE). The Athletic Training program has chosen to voluntarily withdraw its CAATE Accreditation effective June 1, 2023. Students must complete the program and graduate prior to this date. Graduates with the Athletic Training major (2023 and prior) are eligible to sit for the Board of Certification (BOC, Inc.) exam.
