SOCIAL WORK

PROGRAM OVERVIEW

Capital's social work program adheres to the principle that education for social work proceeds from a common core of values and knowledge incorporated into practice. Our goal is to bring graduates into the profession who are able to make responsible decisions in a rapidly changing society.

CAREERS AND PLACEMENT

Our graduates are successful in finding work soon after graduation, and some are employed at the agency where their field placement occurred. The social work program prepares graduates for work in various places, including mental health clinics, public welfare agencies, courts, correctional institutions, child and family services, the Peace Corps, schools, hospitals, substance use treatment centers, and vocational and rehabilitation centers.

EXPERIENTIAL LEARNING

A two-semester field practicum experience is required during the senior year. We have strong ties to agencies that provide students with rich field placements in a variety of areas. Students are encouraged to participate actively with faculty, administration, and local community representatives in policy formation, as well as program and curriculum development and assessment. Opportunities also exist to study abroad internationally.

ADMISSION REQUIREMENTS

Students may declare a social work major, but a formal admission process into the BSW program is required before the end of the sophomore year. All prerequisite and Signature Learning courses must be met before beginning field education. Field Education application and approval is required before the field placement process begins. A minimum of 2.5 GPA is required for social work majors and nothing below a C is required for psychology, sociology, research courses, and all social work courses, including those transferred in as equivalent courses. A minimum of 124 semester hours is required for a bachelor's degree in social work.
