- Scrutinize, identify, create, and advocate for access to anti-oppressive, anti-racist, pro-human rights social policies at the micro, mezzo, and macro levels of practice.

## TUITION AND FINANCIAL AID

- Tuition is assessed on a per credit hour basis. The tuition rate for the 2024-2025 academic year is \$710 per credit hour

- Personal statement that addresses your desire to pursue higher education in Social Work
