

## **SUMMARY ANNUAL REPORT**

### **For CAPITAL UNIVERSITY WELFARE BENEFIT PLAN**

This is a summary of the annual report of the CAPITAL UNIVERSITY WELFARE BENEFIT PLAN, EIN 31-4379435, Plan No. 501, for period 01/01/2018 through 12/31/2018. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

CAPITAL UNIVERSITY has committed itself to pay certain self-funded Medical claims incurred under the terms of the plan.

#### **Insurance Information**

The plan has contracts with UNUM LIFE INSURANCE COMPANY OF AMERICA, DELTA DENTAL OF OHIO, NATIONAL GUARDIAN LIFE INSURANCE COMPANY, and UNITED OF OMAHA LIFE INSURANCE COMPANY to pay Dental, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, and Long Term Care claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2018 were \$412,824.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2018, the premiums paid under such "experience-rated" contracts were \$324,088 and the total of all benefit claims paid under these contracts during the plan year was \$227,344.
